I have provided information on my child's special needs (Allergies, Diet, Disabilities, and/or Medical Information) to the provider, as may be necessary to assist the facility in properly caring for my child in case of an emergency. I agree to review and update this information whenever a change occurs and at least once every twelve months.

The information on this form is complete and accurate. I have provided the YMCA with all of the necessary information to properly care for my child's needs. I must notify the YMCA staff immediately of any changes on this form.

The YMCA's responsibility for my child begins when the child has reached the program and checked in with YMCA staff. My child is responsible for walking from the bus or classroom to the YMCA program.

It is my responsibility to arrange for any necessary transportation with the school my child attends.

It is my responsibility to notify the YMCA staff if my child will be absent from the program.

It is my responsibility to arrange for my child to be picked up from the program before closing.

If my child is not picked up on time and attempts to contact me have failed, another authorized person will be contacted. If all attempts to contact an authorized person to pick up my child have failed, the YMCA staff will contact Child Protective Services and/or police officials for further instructions.

Should a person arrive to pick up my child who appears to be under the influence of drugs or alcohol, for the child's safety, staff may have no recourse but to contact the police.

The YMCA is mandated, by state law, to report any suspected cases of child abuse or neglect to the appropriate authorities for investigation.

I understand and agree to the child care conduct, transportation, and participation policies as outlined in the parent handbook. I am aware that a hard copy of the handbook is available upon request. The YMCA has permission to use photographs and videos of my child in promotional materials such as brochures, ads, YMCA website, or newspaper releases.

It is further warranted that such entry into the YMCA for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated program have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation.

- ⇒ Any changes in sites must be reported to your DES case worker at minimum, two weeks prior to location change in order for the YMCA to submit for payment. Parent or Guardian will be held financially responsible for any non-payment from DES.
- ⇒ Please be aware that our Summer Camp days are billed as full days (6 hrs or more) and it is helpful in keeping costs low if your child attends at least 6 hours per day for DES billing purposes.
- ⇒ All signatures on sign in/out sheets must be legal signature (signature on driver's license), fully legible, and exact times used.
- ⇒ Any dates of service used after a DES stop date is issued will be billed at the full rate and parent or guardian will be held financially responsible for all fees incurred.
- ⇒ DES allows two paid absences per month, anything exceeding will be the parent or guardian's financial responsibility:
\$23 full day (6hrs +) OR \$15/half day (less than 6hrs)
- ⇒ Any unpaid DES co-pays will be reported to your DES caseworker.

Frequently Asked Questions

1. How much does summer camp cost?

New this year, we are offering tier pricing. Please see page 3 for specific details.

2. Do you offer financial assistance?

Yes, the YMCA offers a scholarship assistance program to families in need. Please visit the front desk for the scholarship application and allow up to 30 days to hear back.

3. What time is pick up and drop off? What should my child bring to camp each day?

Normal programming hours are 9:00 a.m. to 4:00 p.m. with drop off available as early as 7:00 a.m. and pick up as late as 6:00 p.m.

Please send your child in comfortable clothing, closed toed shoes, water bottle, hat and sunscreen each day. Have them also bring a bathing suit, towel and goggles on swim days.

4. Do we need to bring a lunch and snacks?

Lunch is ONLY provided at the Ott YMCA location from June 4-July 20, as they are part of the TUSD summer food program. Lighthouse YMCA, Desert Christian and Cottonwood DO NOT provide lunch, please bring a sack lunch each day.

Snack is provided each day during the morning and afternoons at all 4 sites.

5. How often do they swim?

The swim schedule will vary by location. The specific schedule will be available by May 1st. We want the children and members to get the most use out of the pools and we appreciate your patience and forming the right schedule to fit all the YMCA needs.

6. When and where are the field trips each week?

The field trips will vary by location. Please see page 8 for specific details.

7. What is the cancellation policy?

We require a minimum 2 week cancellation for charges to be cancelled and not applied.

The cancellation form is located on page 10.

8. What if my child is sick or doesn't attend?

If your child becomes sick please give us a call so we can let their group leader know. We do not refund or transfer daily fees for non-attendance.

9. Is the deposit and fees non-refundable?

Both the deposits and fees are non-refundable and non-transferable.

10. What information is needed if my child takes medication during camp hours?

If you child needs medication during camp hours, please fill out the medical consent form. The medication **MUST** be prescribed and in the original prescription bottle or box, including children with asthma that require inhalers.
