FINANCIAL POLICY & PARENT AGREEMENT

- **Membership Options** A membership is required at the time of registration, please see our member service staff for membership options.
- **Payments** All payments are due weekly prior to attending camp. Automatic Transfer System (ATS) are processed every Friday prior to the week your child will be in attendance. If payments are not kept current, a \$25.00 late fee will be charged. If fees have not been paid within one week, childcare services will be discontinued until account is brought current.
- **Absences** **A written one week notice must be given upon disenrollment or absence.** There are no credits for daily absences, as this is a weekly program. If a child does not attend for a week or more, the parent will be charged the weekly rate (this is due to saving your spot in our program).
- **Deposits** Your 1st week's tuition plus a non-transferrable/non-refundable deposit per week that you would like your child to attend is required at time of registration. The deposit will be applied towards your weekly tuition.
- **Refund Policy** When you enroll, you are reserving the time, space, staffing, and provisions for your child whether he/she attends or not. Therefore, the Office Manager will review requests for refunds on case-by-case basis.
- **Late Pick-Up** Late pick-up fees of \$5.00 per minute/per child will be charged after 6:00pm.
- **Returned Checks** All insufficient funds/returned checks will be charged a \$25.00 service fee and childcare services will discontinue until the account is brought current.
- **Subsidies** If you receive DES child care, an authorization must be obtained before registration.

Behavior Agreement

At the YMCA we take the happiness of your children very seriously. We want every day here to become a happy memory for them. Therefore, we work hard at creating an environment that will allow this to happen. Along with our efforts, we need the children to help us create that environment by following some simple, but effective rules. Below is our Behavior Agreement, please read over it with your child and be sure they understand what it is and why they are signing it. This will help us help them have a wonderful experience at YMCA Summer Camp! **Thank you!**



- I will listen to the staff and follow their directions
- I will respect other people's belongings by not touching/using their stuff without permission
- I will not hit or fight with other campers
- I will not yell while inside the campsite building and will use my inside voice while speaking
- I will use appropriate language which **does not** include swear words or negative remarks
- I will ask permission from a staff member before leaving the room
- I will respect other's feelings by having a positive attitude when talking to them

Not abiding by these rules can result in suspension from the program. All incidents will be handled on a 3-incident system, except hitting/fighting. Hitting/fighting will be an immediate one day suspension from the program. All other incidents will be handled as follows:

- 1st Incident: **VERBAL WARNING**
- 2nd Incident: **WRITTEN WARNING/PARENT MEETING**
- 3rd Incident: **ONE DAY SUSPENSION**

At the camp director's discretion, campers that receive 3 written warnings during a session may be asked to leave the program for the remainder of the session.
